Dear Mr. Kugler:

Attached please find two invoices from M & M Court Reporting Service, Inc for the cost involved in transcribing the following:

The Department expects to lodge the record and the transcript with the agency no later than September 30, 2011. Pursuant to Rule 84(g)(1)(A) of the Idaho Rules of Civil Procedure (I.R.C.P.), which reads as in pertinent part:

...the petitioner shall pay the estimated fee for preparation of the transcript as determined by the transcriber prior to the filing of the petition for judicial review, and the petitioner shall pay the balance of the fee for the transcript upon its completion.

Furthermore, I.R.C.P. 84(j) states:

...the agency shall mail or deliver a notice of lodging of transcript and record to all attorneys of record or parties appearing in person and to the district court. The notice shall inform the parties before the agency that they pick up a copy of the transcript and record at the agency and that the parties have fourteen (14) days from the date of the mailing of the notice in which to file with the agency any objections, and the notice shall further advise the petitioner to pay the balance of the fees for the preparation of the transcript, if any, and the record, if any, before the copy of the transcript and the record will be delivered to the petitioner.

As such, please remit a check made payable to the Department of Water Resources in the amount of \$522.00. As a courtesy and given your location, the Department will mail your copy of the agency record upon timely receipt of your payment.
