On December 2, 2008, attorneys with Racine Olson Nye Budge & Bailey, Chtd. filed a *Petition to Intervene* in the above-captioned matter on behalf of the Aberdeen-American Falls Ground Water District, the Bingham Ground Water District, the Bonneville-Jefferson Ground Water District, the Clark-Jefferson Ground Water District, the Madison Ground Water District, and the Aberdeen-Springfield Canal Company.

On December 9, 2008, attorneys with Holden Kidwell Hahn & Crapo PLLC filed a *Petition to Intervene* in the above-captioned matter on behalf of the Mud Lake Water Users, Independent Water Users, Jefferson Canal Company, Montevue Canal Company, Producer's Canal Company, and Fremont-Madison Irrigation District.

The joint water right holders in this case, the Twin Falls Canal Company and the North Side Canal Company (hereinafter "Canal Companies"), have requested a schedule to file responses to the above-referenced petitions to intervene and a hearing on the same. 
