



The parties to the above entitled action submitted for the Department’s approval a **STIPULATION TO VACATE AND RE-SET HEARING AND CORRESPONDING STIPULATED SCHEDULE**. The hearing officer has reviewed the Stipulation and hereby approves the Stipulation to Vacate and re-Set Hearing and Corresponding Stipulated Schedule. The new Hearing dates and corresponding schedule in this matter shall be as follows:

1. On August 28, 2009, a Scheduling Order was entered in this action setting the Hearing of this matter for four days commencing February 23, 2010. The parties to this action hereby agree to vacate the hearing as currently set, and re-schedule the hearing for four days beginning May 4, 2010.
2. Hearing on any Motions for Summary Judgment shall be heard March 12, 2010, at 10:00 a.m. The timing for filing any Motions for Summary Judgment and the responses and briefing shall comply with the Idaho Rules of Civil Procedure.
3. Discovery, including the answers to requests for discovery, shall conclude by February 26, 2010. The conduct of discovery shall comply with the Idaho Rules of Civil Procedure.
4. A further Status Conference shall be held upon the request of any party.


