COME NOW the parties, through their undersigned attorneys, and stipulate and jointly move the Court to enter an Order allowing Rangen, Inc. to file a single opening brief and reply brief covering its appeal and cross appeal in this matter. As grounds, the parties state as follows:

1. Petitions for judicial review filed by the Idaho Ground Water Appropriators, Inc. (“IGWA”) and Rangen, Inc. (“Rangen”), Gooding County Case No. CV-2014-179 and Twin Falls County Case No. CV-2014-1338, respectively, are pending before this Court.
2. Rangen has also filed a Petition for Cross Appeal in Gooding County Case No. CV-2014-179.
3. Gooding County Case No. CV-2014-179 and Twin Falls County Case No. CV-2014-1338 have been consolidated for purposes of the agency record only under Case No. CV-2014-1338.
4. The petitions seek review of the same orders entered in the Rangen delivery call before IDWR, Docket No. CM-DC-2011-004: 1) *Final Order Regarding Rangen, Inc.'s Petition for Delivery Call; Curtailing Ground Water Rights Junior to July 13, 1962* issued on January 29, 2014; and 2) *Order on Reconsideration* issued on March 4, 2014. In its Cross Appeal in Gooding County Case No. CV-2014-179, Rangen also, out of an abundance of caution, seeks review of the *Order Granting in Part and Denying in Part Rangen, Inc's Motion for Partial Summary Judgment Re: Source*.

5. To facilitate orderly briefing, the parties stipulate and agree to allow Rangen to file a single opening brief and reply brief appealing from all orders and addressing all issues raised in Rangen's Petition for Judicial Review and Cross Petition for Judicial Review. The briefs will be filed in Twin Falls County Case No. CV-2014-1338. All responses by other parties to Rangen's briefing will be filed in the same case. Rangen will only file a response brief to IGWA's Petition for Judicial Review in Gooding County Case No. CV-2014-179.

6. This briefing arrangement would expedite the matter and minimize the expense incurred by the parties.
