On October 4, 2012, the Director of the Department of Water Resources ("Director") was notified by Department staff of a data error in the Eastern Snake Plain Aquifer Model 2.0. On the same day, the Director entered an order suspending the scheduling order in this matter and setting a status conference.

The status conference was held on October 10, 2012. At the status conference, the parties agreed to a status/scheduling conference after the next ESPAM committee meeting. The parties also agreed to a November 30, 2012 deadline for the filing of opening expert witness reports. The parties and the Director recognized that the November 30<sup>th</sup> deadline may need to be adjusted depending on the results of the ESPAM committee meeting.

**ORDER**

Based upon the foregoing, IT IS HEREBY ORDERED that opening expert reports are due November 30, 2012. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and

executable codes for all models and utilities, and configuration or file settings for models and utilities.

IT IS FURTHER ORDERED that a Status/Scheduling Conference is scheduled for **November 14, 2012 at 1:30 p.m. (MDT)**, to be held in the Director's conference room at the Idaho Department of Water Resources' state office, located at 322 E. Front Street, 6<sup>th</sup> Floor, Boise, Idaho.

All parties to the matter must be represented in person or by telephone. If participating by telephone; dial **1-215-446-0193** and provide participant code **275568#** when prompted.

The conference will be conducted in accordance with the accessibility requirements of the Americans with Disabilities Act.
