On June 12, 2012, the Director of the Idaho Department of Water Resources (“Director”) issued a Scheduling Order in this matter.

On August 31, 2012, the parties filed a *Stipulation to Amend Scheduling Order* asking the Director to extend the opening expert report deadline from October 3, 2012, to October 10, 2012. The Director grants the request and the new amended schedule is as follows:

- 6/8/12 – Discovery opens
- 10/10/12 – Opening expert reports due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or settings files for models and utilities.
- 10/31/12 – Dispositive Motions deadline
- 11/14/12 – Response to Dispositive Motions, if any
- 11/21/12 – Rebuttal expert reports. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or settings files for models and utilities.
- 11/26 to 11/30/12 – Dates for expert depositions
- 12/4/12 – Hearing on Dispositive Motions, if any

- 12/14/12 – Staff memo due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or settings files for models and utilities.
- 1/2/13 – 1/4/13 – IDWR Staff depositions<sup>1</sup>
- 1/11/13 – Witness and exhibit lists exchanged
- 1/18/13 – Responses to staff memo due
- 1/21/13 – Pre-hearing conference and pre-hearing briefs due
- 1/28/13 – Hearing begins

Based upon the foregoing, IT IS HEREBY ORDERED that the above amended schedule is ADOPTED.


