Dear Dan:

I apologize for the time that has gone by, but it has been difficult to arrange and coordinate schedules with our hydrologist, Charles Brockway. Mr. Brockway met with myself and the hatchery staff on June 7, 1995, and has promised to get me a proposal as to the feasibility of the plan we suggested at the last hearing, that being to allow all of the water out of Curren Tunnel to flow down through Rangen's hatchery facility and to be pumped back up to the entrance of the tunnel to then be provided to Candy, Musser and Crandelmier. Mr. Brockway has indicated that the project looks good, but needs some time to do elevation shots and gather other engineering data to put together a proposal for the Department of Water Resources which then be made to Candy, Crandelmier and Musser.

It is going to take longer than June 29 to gather that information. However, it looks very probable that it may work at this point in time. What I would like to suggest is a stipulation to continue that June 29 hearing. To that end I have enclosed such a stipulation for you to review. If it looks in order, could you please execute and return it to me. However, if there are some concerns or you do not feel a continuance is in order, please let me know and I will make a formal motion to the Court.
