

Idaho Ground Water Appropriators, Inc. (IGWA) submits this response to *Rangen's Request for Emergency Status Conference* filed February 7, 2013. IGWA does not object to Rangen's request for a status conference. However, IGWA does object to suspension of the rebuttal report deadline. All parties have been preparing rebuttal reports to meet the current deadline of February 8, 2013 (which was already extended from February 1, 2013 at Rangen's request).
