COMES NOW, the Petitioner, A&B Irrigation District (“A&B”), by and through its undersigned counsel, and pursuant to I.R.C.P. 84(j) hereby submits this *Objection to Agency Record*. The Idaho Department of Water Resources (“IDWR”) lodged the record with the Court by letter dated November 13, 2012. In its letter, IDWR recited its understanding of the agency record on appeal in this case.

A&B agrees in part with IDWR’s assessment of the agency record in this case. A&B agrees the following documents referenced in IDWR’s letter should be included in the agency record:




