




On June 14, 2012, this Court entered an *Order* staying the proceedings in the above-captioned matter. On October 29, 2013, the Surface Water Coalition<sup>1</sup> filed a *Joint Motion to Lift Stay / Joint Motion to Expedite* requesting that (1) the stay be lifted, and (2) its *Motion to Lift Stay* be heard on an expedited basis.
