Remark: Proposes up to 4 new wells about 700 ft. deep for Elk Creek Village, phase 1 of Elk Creek Canyon planned community (other phases to be covered by other pending applications not processed yet). Wells and proposed development will be in northwest corner of Mt. Home Ground Water Management Area. Application covers about 1200 domestic equivalent units with about 138 acres of associated irrigation and other uses within municipal definition. Phase 1 is projected to include annual diversions of about 580 acre-feet of ground water. Project located north of 184 near Simco Road.

Permits will be subject to all prior water rights. Protests may be submitted based on the criteria of Sec 42-203A, Idaho Code.


