Remark: Proposes up to 8 wells for a
planned community north of I84 and Simco
Road. Wells will be near but outside of the
Mtn. Home Ground Water Management Area.
Wells will be in Elmore County but the project
is generally near the Ada and Elmore County
lines. About 8000 units are proposed. Esti-
mated annual use will include about 4860 acres
feet diversion volume (about 3960 consump-
tive volume). Existing irrigation rights within
the site will be used. Municipal use is for ap-
plicants service area. Water bearing zone to be
appropriated is from 200 to 1200 feet.

Permits will be subject to all prior water
rights. Protests may be submitted based on the
criteria of Sec 42-203A, Idaho Code.

Any protest against the approval of this ap-
plication must be filed with the Director, Dept.
of Water Resources, Western Region, 2735
Airport Wy, Boise ID 83705 together with a
protest fee of \$25.00 for each application on
or before 06/23/2008. The protestant must also
send a copy of the protest to the applicant.


