**ORDER GRANTING
REQUEST FOR ORAL
ARGUMENT**

The City of Eagle ("Eagle") and Joseph, Lynn and Michael Moyle ("Moyles") filed petitions for reconsideration with the Director of the Idaho Department of Water Resources ("IDWR") following the issuance of a final order in the above titled matter and requested oral argument. The Director granted the request for oral argument, and scheduled the argument for May 7, 2008.

Mary Taylor and Charles Howarth wrote letters to the Director requesting permission to appear and present oral argument on May 7, 2008. The Department sent copies of the requests to counsel for Eagle and Moyles. Following receipt of comments from counsel for Eagle and Moyles, the Director determines that restricted presentation of oral argument by Mary Taylor and Charles Howarth will not prejudice the other parties and will enhance his understanding of their respective positions in the contested case.


ORDER


