On December 19, 2006, the Director of the Idaho Department of Water Resources ("IDWR") filed his *Part I Director's Report, Reporting Areas 13, Basin 63*, which included a recommendation for a General Provision. No *Objections* were filed to the General Provision recommendation. On November 19, 2013, the Special Master entered a *Special Master's Report and Recommendation*, recommending that the General Provision for Basin 63 be decreed as set forth in the attached *Recommendation for Partial Decree Pursuant to I.R.C.P. 54(b) for General Provision in Basin 63*. No Challenges were filed to the *Special Master's Report and Recommendation* and the time for filing Challenges has now expired.

Pursuant to I.R.C.P. 53(e)(2) and *SRBA Administrative Order 1*, Section 13f, this Court has reviewed the Findings of Fact and Conclusions of Law contained in the *Special Master's Report and Recommendation* and wholly adopts them as its own.

Therefore, IT IS ORDERED that Basin 63 General Provision be decreed as set forth in the attached *Partial Decree Pursuant to I.R.C.P. 54(b)*.

PARTIAL DECREE PURSUANT TO
I.R.C.P. 54(b) FOR GENERAL

The following general provisions are hereby decreed to be applicable to water rights in Basin 63:

The following water rights from the following sources of water in Basin 63 shall be administered separately from all other water rights in Basin 63 in accordance with the prior appropriation doctrine as established by Idaho law:

WATER SOURCE: Smith Creek and Tributaries






