On January 27, 2015, the Director (“Director”) of the Idaho Department of Water Resources (“Department”) held a status conference at the Department’s state office related to the above captioned matter.

On February 3, 2015, the Director issued an *Order Setting Briefing Deadlines* (“Order”). The Order requested additional briefing from parties on certain issues and set the following briefing schedule:

- Deadline for submission of initial briefs February 10, 2015
- Deadline for responses February 24, 2015
- Deadline for replies February 27, 2015

On February 4, 2015, Rangen, Inc. (“Rangen”), filed *Rangen, Inc.’s Request for Clarification of Briefing Schedule* (“Request”). In the Request, Rangen states the Order “does not appear to take into account the order of briefing decided at the status conference.” *Request* at 2. Rangen states it was agreed at the status conference that “Intervenors submit briefing first and that Rangen then be permitted to respond and the Intervenors, if they desired, could submit replies.” *Id.* Rangen requests the Director clarify that the deadline for submission of initial briefs and replies applies to the parties that have intervened in the proceeding and the deadline for responses applies to Rangen. *Id.*

The Director's recollection is consistent with Rangen's statements regarding the status conference. It is the Director's intent that the deadline for submission of initial briefs and replies applies to the parties that have intervened in the proceeding and the deadline for responses applies to Rangen.


