Angelina M. Leavitt, of her own personal knowledge and duly sworn, states:


1. I am the Secretary/Clerk of the North Snake Ground Water District ("North Snake"). My July 14, 2005 affidavit, previously filed in this matter, provides more detail about my duties with North Snake, and these will not be repeated here.
2. Pursuant to the Director's recent order allowing North Snake additional time to do so, I have been working with North Snake members to produce and sign, with the Water District 130 Watermaster, the "joint requests" pertaining to ground water use on conversion projects in compliance with the Director's July 6, 2005 *Order Approving IGWA Substitute Curtailment Plan*

(Blue Lakes Delivery Call) ("July 6 Order"). I am submitting such requests together with this affidavit.


3. However, I am aware of one member, Frank Veenstra, who has been out of the state and on vacation over the last two weeks and is not scheduled to return until July 30, 2005. Mr. Veenstra's secretary informed me that she will not contact Mr. Veenstra during this period unless it is a family emergency, and that this situation does not qualify. Accordingly, I cannot include Mr. Veenstra's joint request with those I am submitting to the Department in time to meet the July 29, 2005 deadline.


