**ORDER ON RECONSIDERATION
CONFIRMING FINAL ORDER
ISSUED FEBRUARY 26, 2008**

The applicant City of Eagle (“Eagle”) and protestants Joseph, Lynn and Michael Moyle (“Moyles”) filed timely petitions for reconsideration with the Director of the Idaho Department of Water Resources (“Director”) following the issuance of a Final Order in this matter on February 26, 2008. The Director issued an order on March 25, 2008, granting the petitions for reconsideration, setting a briefing schedule and setting oral argument. The parties submitted briefs and subsequently presented oral argument before the Director on May 7, 2008 in support of their respective petitions for reconsideration.

The Director having carefully reviewed and considered the briefs of the parties in support of the petitions for reconsideration and the oral arguments presented determines that no change should be made to the Final Order of February 26, 2008.

ORDER

IT IS THEREFORE ORDERED that the respective requests of the parties on reconsideration seeking modifications to the Final Order issued by the Director on February 26, 2008 in this matter are DENIED.

IT IS FURTHER ORDERED that pursuant to Sections 67-5270, 67-5272 and 67-5273 Idaho Code, any party aggrieved by this order and the Final Order issued by the Director in this matter on February 26, 2008, may appeal the orders to district court by filing a petition for judicial review within twenty-eight (28) days of the service date of this order




