On September 11, 2012, the Director of the Idaho Department of Water Resources (“Director”) issued an Amended Scheduling Order in this matter.

On November 2, 2012, the parties filed a *Stipulation and Joint Motion to Enter Scheduling Order* asking the Director to extend deadlines to the litigation schedule in this matter and for the Director to issue a scheduling order in accordance to the stipulation.

The new amended schedule is as follows:


- 11/30/12 – Opening expert reports due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- 01/11/13 – Rebuttal expert reports due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- 1/21/13 – 2/1/13 – Dates for expert depositions.
- 2/1/13 – IDWR staff memo due. Data and modeling files used or relied upon in all opinions shall be provided in conventionally accessible and readable electronic form, suitably named and indexed to facilitate their review. These files shall include all model input and output data, source and executable codes for all models and utilities, and configuration or file settings for models and utilities.
- 2/11/13 – 2/15/13 – IDWR staff depositions.

- 2/22/13 – Responses to staff memo due.
- 3/8/13 – Dispositive motions deadline.
- 3/22/13 – Dispositive motions response briefs due.
- 3/29/13 – Dispositive motions reply briefs due.
- 4/3/13 – Hearing on dispositive motions.
- 4/8/13 – Witness lists and exhibits exchanged.
- 4/19/13 – Pre-hearing briefs due.
- 4/22/13 – Pre-hearing conference.
- 5/1/13 – Hearing begins.
- 5/15/13 – Hearing ends.

Based upon the foregoing, IT IS HEREBY ORDERED that the above amended schedule is ADOPTED.


