ANNUAL MEETING 75 C 2008

MEETING WAS CALLED TO ORDER BY CHAIRPERSON VIRGINIA PERRY AT 7:10 P.M. MARCH 3, 2008.

6 MEMBERS WERE PRESENT: JACK PARMENTER, ROY HOFFMAN, FRED JAKOVAC, JERRY PERRY, PAUL EDWARDS AND VIRGINIA PERRY.

PAUL EDWARDS MADE THE MOTION AND ROY HOFFMAN SECOND THAT VIRGINIA PERRY WAS RETAINED AS SECRETARY WITH A RAISE IN PAY TO \$300.00 PER YEAR.

FRED JAKOVAC MADE THE MOTION AND JACK PARMENTER SECOND THAT JERRY PERRY WAS RETAINED AS WATERMASTER WITH A RAISE IN PAY TO \$800.00 PER YEAR.

CLEANING OF THE DITCH WAS DISCUSSED; IT WILL BE CLEANED FROM CHAFFINS DOWN TO JACKICHS. THE DITCH FROM THE SPLITTER BOX WEST TOWARD S. ST. CHARLES WILL BE CLEANED .

IT IS HOPED THAT THE REMOVAL OF THE BRUSH FROM THE SIDE OF THE DITCH IN AUSTINS PROPERTY WILL HELP ELIMINATE THE MOSS AND SANDBARS. THE WATERMASTER WILL CHECK ON THE RESULTS AS SOON AS THE ICE IS GONE FROM THE DITCH.

THE FACT THAT THE LATERALS ARE NOT BEING CLEANED WAS TALKED ABOUT. THE SECRETARY WILL ADD A REMINDER TO THE 2008 STATEMENTS; THAT THE DITCH COMPANY IS NOT RESPONSIBLE FOR CLEANING THESE DITCHES. THE PEOPLE ON THE LATERALS ARE RESPONSIBLE.

DO TO THE FACT THAT WE HAD A VERY HIGH WIND LAST YEAR AND A LOT OF TREES WERE BLOWN OVER; THE WATERMASTER HAD TO CUT A FEW OFF SO THE HIGH WATER WILL NOT TAKE OUT THE NEW DITCH. ROY HOFFMAN ALSO CUT OFF A BUNCH IN THE JAKOVAC PROPERTY.

PAUL EDWARD MADE THE MOTION AND FRED JAKOVAC SECOND THAT THE ASSESMENT FOR 2008 WILL BE SET AT \$7.00 PER ACRE AND \$7.00 PER ASSESSMENT FOR WORKMANS COM.

PAUL EDWARDS, ROY HOFFMAN AND LARRY LEAVITT WERE APPOINTED TO THE DITCH COMMITTEE.
