NOTICE OF HEARING


On August 30, 2016, the Idaho Department of Water Resources ("Department") received a written complaint from Mr. Colby Clark ("Complainant") requesting removal of the current watermaster of Water District 95C ("WD95C"), Laurin Scarcello ("Watermaster"). On November 3 and 4, 2016, the Department commenced a hearing to gather testimony from the Complainant, the Watermaster, and others to determine whether the Director should remove the Watermaster pursuant to Idaho Code § 42-605(9). However, the hearing was not completed within the scheduled two days. At the end of the hearing session on November 4, 2016, the Complainant, the Watermaster, and the other participants agreed they would be available to continue the hearing on November 10, 2016.

THEREFORE, PLEASE TAKE NOTICE that the hearing will resume on November 10, 2016, at 9:00 a.m. at the Twinlow Camp & Retreat Center, 22787 N. Twinlow Road, Rathdrum, ID, 83858.

The hearing will be held in accordance with provisions of Chapter 17, Title 42, and Chapter 52, Title 67, Idaho Code, and the Department's Rules of Procedure, IDAPA 37.01.01. The hearing will be conducted in accordance with the accessibility requirements of the Americans with Disabilities Act.
