At this status conference, petitioner LynClif Farms, respondent City of Pocatello, and intervenor Idaho Ground Water Appropriators, Inc. collectively requested a delay of formal proceedings in this matter and stipulated to the setting of a continued status conference in January 2015 in order to obtain water modeling information and attempt to resolve the delivery call filed by LynClif Farms.


