**ORDER VACATING
STATUS CONFERENCE**

On August 26, 2014, the Director (“Director”) of the Idaho Department of Water Resources (“Department”) set a status conference in this matter to be held on January 8, 2015.

On November 12, 2014, the Director received a *Stipulated Mitigation Plan and Request for Order* and a *Stipulation for Dismissal* filed jointly by Aquarius Aquaculture, Inc. (“Aquarius”), the North Snake Ground Water District, Magic Valley Ground Water District, Southwest Irrigation District and the Idaho Ground Water Appropriators, Inc.

On November 24, 2014, the Director issued a *Final Order Approving Mitigation Plan and Dismissing Delivery Call* (“Final Order”). No appeal of the order was filed and it is now effective. Idaho Code § 67-5246. The Final Order did not expressly vacate the previously scheduled status conference in this matter.

Staff for the Department contacted David Huff, vice-president of Aquarius, and Huff confirmed that no further action is needed with regards to the delivery call and that the status conference is not necessary.

ORDER

IT IS HEREBY ORDERED that the status conference set for January 8, 2015, is hereby VACATED. As no further action is necessary with regard to the delivery call, the Department will close its file on the matter.


