

Pocatello also owns and operates associated surface water rights, including rights to water stored in Palisades Reservoir. Pocatello accordingly has a direct and substantial interest in how the Department accounts for storage in Water District 1.


Pocatello respectfully requests the Director enter an order granting this petition to intervene.
