

Aberdeen-Springfield Canal Company (ASCC) hereby petitions to intervene in this matter pursuant to Rules 350-354 of the Rules of Procedure of the Idaho Department of Water Resources (IDWR).

Rule 350 authorizes intervention by anyone who claims “a direct and substantial interest in the proceeding.” ASCC owns storage water rights in the Federal on-stream reservoirs in Water District 1. The manner in which the IDWR accounts for storage may affect the timing and quantity of water available to ASCC under its storage water rights. Thus, ASCC has a direct and substantial interest in this proceeding. ASCC’s interest is not adequately represented by other parties, because storage water accounting practices and related rental rules affect different storage holders differently, depending on priority dates, natural flow water supplies, and other factors.


