**UNITED WATER'S FURTHER
SUBMISSION IN COMPLIANCE WITH
THE DIRECTOR'S JANUARY 11, 2013
ORDER**

Pursuant to the Director's January 11, 2013 *Order Denying Motion to Dismiss Integrated Municipal Application Package (IMAP)* ("Order"), Applicant United Water Idaho Inc. ("United Water") submits *United Water's Further Submission in Compliance with the Director's January 11, 2013 Order* ("Further Submission") including the attached spreadsheets, Attachments A and B, and the attached map, Attachment C, to supplement the information contained in *United Water's Statement Updating and Explaining the IMAP Relaunch* (Aug. 14, 2012) ("Update Statement").

As required by the *Order*, United Water met with Department staff to identify and explain the changes to the IMAP described in the *Update Statement*, and to determine how the information could be further explained and organized to show the contents of the IMAP's permit

amendment and transfer applications. In accordance with Department staff's instructions at that meeting, United Water produced and submitted for staff review Attachments A, B, and C. Department staff has confirmed that the spreadsheets in Attachments A and B adequately describe the contents of the IMAP's permit amendment and transfer applications, and that no further documentation is necessary to update or amend the IMAP. Department staff also has confirmed the sufficiency of the map in Attachment C. Except for a few minor corrections and clarifications described below, the information in Attachments A, B, and C, is not substantively different than the information in the *Update Statement's* Exhibits C, D, and F. The sections that follow contain further discussion about the contents of Attachments A, B, and C, and why the updates to the IMAP do not require re-advertisement.

United Water respectfully requests that the Director proceed with processing the IMAP without additional legal notice or delay.

I. THE ATTACHMENTS

A. Attachment A—the Summary Spreadsheet

Attachment A (the "Summary Spreadsheet") contains a list of all 106 water right decrees, licenses, and permits currently included in the IMAP. It shows the elements of the rights as they currently exist (i.e., "before transfer") and as they are proposed to change if the IMAP is approved as requested (i.e., "after transfer"). Except as described below, the information in the Summary Spreadsheet is identical to the information presented in Exhibit C to United Water's *Update Statement*. The differences are as follows:

1. The Summary Spreadsheet shows only the decreed, licensed, and permitted water rights included in the IMAP. Unlike the *Update Statement's* Exhibit C, it does not show the water rights in United Water's portfolio that are not included in the IMAP. Please see the *Update Statement*, at 42-47, for a discussion about United Water's water rights and entitlements

that are not included in the IMAP. The Summary Spreadsheet also omits certain other information contained in the *Update Statement's* Exhibit C, such as information describing the rights' elements as they existed when the IMAP was stayed in 2003. In other words, the Summary Spreadsheet contains less information than was previously provided. It has been streamlined, at the request of Department staff.

2. The Summary Spreadsheet shows different "after transfer" diversion rates for right nos. 63-04395, 63-08385, and 63-10150 than was displayed in the *Update Statement's* Exhibit C. The differences result from the proposed elimination of a 240.3 AFY combined annual volume limitation that United Water inadvertently overlooked in preparing the *Update Statement*. As explained in the Summary Spreadsheet's note 3, these rights' diversion rate and annual volume limitations can be eliminated without enlargement by reducing right no. 63-04395 to 0.33 cfs (which is the diversion rate that would produce the rights' 240.3 AFY combined annual volume limitation if diverted continuously year-round) and reducing the other two rights to 0.00 cfs. United Water recognizes that reducing right nos. 63-08385 and 63-10150 to 0.00 cfs effectively relinquishes them.

3. The Summary Spreadsheet shows a different "after transfer" diversion rate for right no. 63-08405. This results from the proposed elimination of a combined diversion rate limitation (with right no. 63-07641), which also serves to eliminate right no. 63-08405's annual volume limit. As explained in the Summary Spreadsheet's note 4, the rights' 3.12 cfs combined diversion rate limitation can be eliminated from both rights without enlargement by reducing right no. 63-08405 (the junior right of the two) to 1.12 cfs, and by keeping right no. 63-07641's diversion rate at 2.00 cfs. Thus, the two rights could pump no more than 3.12 cfs. The reduced diversion rate for right no. 63-08405 also renders moot the 1320 AFY annual volume limitation

on that right. At that rate, the right would produce only 810.9 AFY if diverted continuously year-round. The *Update Statement's* Tables 18 and 21 correctly identified the annual volume and combined diversion rate limitations proposed to be eliminated here, but its Exhibit C accounted only for the elimination of right no. 63-08405's annual volume limitation. This inadvertent oversight is corrected in the Summary Spreadsheet.

4. The Summary Spreadsheet corrects and/or clarifies the following minor, inadvertent errors in the *Update Statement's* Exhibit C:

- a. Right no. 63-04752's priority date is now correctly listed in the Summary Spreadsheet as 7/1/1947; it was incorrectly listed in the *Update Statement's* Exhibit C as 1/1/1947.¹
- b. Right no. 63-11878's point of diversion description in the Summary Spreadsheet now correctly reflects the SENW of Section 8, T4N, R1E; it was incorrectly listed in the *Update Statement's* Exhibit C as Section 7.
- c. The "before transfer" point of diversion descriptions for right nos. 63-02892, 63-12138, 63-12139, 63-31797, 63-31798, and 63-31879, and the "before transfer" place of use descriptions for right nos. 63-12043, 63-12055, 63-12192, 63-12310, and 63-19456 in the Summary Spreadsheet have been updated to more consistently reflect the rights' recorded elements. These descriptions in the Summary Spreadsheet are more accurate, but are not substantively different, than the *Update Statement's* Exhibit C. An illustrative example is right no. 63-12043's place of use

description, which was stated as “Within the service area of United Water Idaho; generally described as the city limits of Boise and surrounding service area” in the *Update Statement’s* Exhibit C, and is more accurately stated as “Within the service area of United Water Idaho” in the Summary Spreadsheet.

B. Attachment B—the APOD List

Attachment B (the “APOD List”) contains a list of the 81 alternative points of diversion (“APODs”) requested in the IMAP. Except as described below, the information in the APOD List is identical to the information in the *Update Statement’s* Exhibit D and the *Update Statement’s* Table 17 on pages 26-28.

1. The APOD List shows only the locations that United Water requests for APOD designation through the IMAP. Unlike the *Update Statement’s* Exhibit D, it does not show the wells or point of diversion locations that have been removed from the IMAP’s APOD request. Please see the *Update Statement*, at 14-28, for a discussion about the requested APODs and which wells and points of diversion are not included in the IMAP.

2. The APOD List corrects and/or clarifies the following minor, inadvertent errors in the *Update Statement’s* Exhibit D and Table 17:

- a. The Maple Hills #2 well’s location is now correctly shown in the SWNENE; it was incorrectly listed as the SENENE in the *Update Statement’s* Exhibit D and Table 17.
- b. The Twenty-Seventh Street well’s location is now correctly shown in the NENW of Section 9, T3N, R2E; it was incorrectly listed in the SWSW of Section 4, T3N, R2E, in the *Update Statement’s* Exhibit D and Table 17.

- c. The APOD List correctly describes the point of diversion located at SWSESE of Sec. 32, T4N, R2E, as the “Veterans well,” as did the *Update Statement’s* Exhibit D; it was incorrectly described as “Veterans Park Ranney collector” in the *Update Statement’s* Table 17, at 28.
- d. The well located in the NWNW of Section 23, T3N, R1E, is correctly described as the “Country Square” well; it was incorrectly described as “Country Squire” well in the *Update Statement’s* Exhibit D and Table 17. In any event, the well names are included solely for convenience of reference. The legal point of diversion is not any particular well, but rather is a legally described location.

C. Attachment C—the Pink Line Map

Attachment C (the “Updated Pink Line Map”) is essentially the same map that was included as the *Update Statement’s* Exhibit F (the “Prior Pink Line Map”). United Water is submitting this new version because Department staff requested larger labels and bolder Township and Range lines to help make the map easier to read. Except for the minor corrections described below, the information in the Updated Pink Line Map is identical to the information in the Prior Pink Line Map.

1. The Updated Pink Line Map does not include the Oregon Trail well that was shown in the NW of Section 31, T3N, R3E, of the Prior Pink Line Map. United Water no longer owns the Oregon Trail well, and the IMAP does not propose to include the well’s location as an APOD. The well was not included as a proposed APOD in the *Update Statement’s* Exhibit D or Table 17, so no change is required here.

2. The Updated Pink Line Map correctly shows the Central Park well in the NW of Section 2, T3N, R2E; it was correctly identified in that location in the *Update Statement’s*

Exhibit D and Table 17, but was incorrectly shown in the SW of Section 35, T4N, R2E, in the Prior Pink Line Map.

3. The Updated Pink Line Map correctly shows the Franklin Park well in the NE of Section 18, T3N, R2E; it was correctly identified in that location in the *Update Statement's* Exhibit D and Table 17, but was incorrectly shown in the NW of that section in the Prior Pink Line Map.

II. ADDITIONAL LEGAL NOTICE IS NOT NECESSARY OR WARRANTED.

In his *Order* at 2, the Director stated that “United Water included several water rights with earlier priority dates in the 2012 Update Statement that were not described in the 2002 legal notice that may need to be advertised.” The “several water rights with earlier priority dates” mentioned in the *Order* are the three rights associated with the Marden Ranney collectors that were decreed during the SRBA process (the “Early Marden Rights”). As described in the *Update Statement* at 23-24, the Marden Ranney collector right no. 63-02892 was split during the SRBA process “into four rights with different priority dates but the same total diversion rate. Thus, in addition to the original license (No. 63-02892), three additional decrees (Nos. 63-31797, 63-31798, and 63-31879) were issued based on beneficial use. All four decreed rights will be included in the IMAP Relaunch.”

Although the Early Marden Rights have priority dates earlier than 1934 (which was the earliest priority date cited in the IMAP’s 2002 legal notice), it is not necessary to advertise them or re-advertise the IMAP because the SRBA process provided ample notice to any potentially affected members of the public. Any water right holder potentially affected by the Early Marden Rights’ priority dates had notice of those priority dates and the opportunity to challenge them through the SRBA process (which no one did).

The only water rights that could be affected by the Early Marden Rights' priority dates are those rights senior to 1952 (the priority date of the Marden Ranney collector right included in the original IMAP). The Early Marden Rights' pre-1952 priority dates are inconsequential to rights junior to 1952 because they are senior in any event and they do not authorize a greater aggregate diversion rate than the original Marden Ranney collector right.

Accordingly, only the holders of pre-1952 rights could complain that the IMAP's 2002 legal notice provided insufficient notice of the Early Marden Rights' priority dates. All of those right holders, however, must have been parties to the SRBA and must have received notice of the Early Marden Rights and their priority dates through the SRBA Court's Docket Sheet procedure. They had ample opportunity to object to any change in priority, and none did.

All valid rights in the Snake River Basin with pre-1952 priority dates must be claimed and decreed in the SRBA. With certain exceptions not relevant to this analysis, the SRBA is an adjudication of "the nature and extent of all water rights within the Snake River Basin within the State of Idaho with a priority date prior to November 19, 1987." *Second Revised Proposed Final Unified Decree* at 9 ¶ 1 (Jun. 28, 2012). Pre-1987 water rights that are not claimed and decreed in the SRBA will be deemed to not exist when the SRBA concludes. *Id.* ("All other water rights with a priority before November 19, 1987, not expressly set forth in this Final Unified Decree are hereby decreed as disallowed.") In other words, anyone with a pre-1952 priority date water right that possibly could be affected by the Early Marden Rights' priority dates must be a party to the SRBA wherein the Early Marden Rights were claimed, recommended, and decreed.

In turn, because all pre-1952 priority date water right holders must be parties to the SRBA, they all must have received notice of the Early Marden Rights through the SRBA Court's Docket Sheet procedure. *SRBA Administrative Order 1* § 6 ("The Docket Sheet Procedure shall

be used to give notice to parties in the adjudication”) The Idaho Supreme Court has held that parties to the adjudication are afforded proper notice and due process under the Docket Sheet procedure. *LU Ranching Co. v. U.S.*, 138 Idaho 606, 610, 67 P.3d 85, 89 (2003) (“The [Docket Sheet] method of notice given was reasonably calculated to give LU Ranching and all other claimants the information to pursue and protect their rights.”)

Here, the Early Marden Rights were recommended by the Department in the December 14, 2006, Director’s Report filed with the Court, notice of which was included in the Court’s January 2007 Docket Sheet. The Orders of Partial Decree for the rights subsequently were included in the Court’s June 2010 Docket Sheet. To paraphrase the *LU Ranching* Court, any complaints concerning notice of Early Marden Rights must be considered as arising from a lack of timely attention, not inadequacy of notice. *Id.*

Re-advertisement is ordinarily required to correct inaccurate or misleading information in the original legal notice. Here, the IMAP’s original 2002 legal notice accurately described the rights included in the IMAP, including the 1952 Marden right. It accurately described the status of United Water’s rights at that time, and the proposed changes that United Water still seeks through the IMAP. No one was misled. United Water should not be penalized because subsequent proceedings have resulted in some evolution of those rights. In proceedings of extended duration, that sometimes happens.

There is no statute or administrative rule or guidance document requiring re-advertisement where, as here, a right in a pending administrative transfer proceeding is split through an adjudication that provided notice to all potentially affected parties. The transfer statute, Idaho Code § 42-222, is silent on the issue of re-advertisement, and the Department has no rules specifically governing transfer applications. The Department’s transfer guidance merely

provides that “[a] re-advertisement fee, as provided in Section 42-221F, Idaho Code, will be required if notice of the original application has been published and changes to the original application are significant and warrant re-notice.” Transfer Processing Memo No. 24 (“Transfer Memo 24”) at 16 (Dec. 21, 2009). The split of the Marden right from one into four right, with no increase in overall diversion rate, is not a change in the IMAP application, let alone a change that would adversely affect other water users. That is an event that occurred outside of the IMAP with notice to all potentially affected parties.

In summary, only water rights with pre-1952 priority dates could potentially be affected by the Early Marden Rights’ priority dates decreed by the SRBA Court. The holders of such pre-1952 rights received notice of the Early Marden Rights through the SRBA’s Docket Sheet, and had an opportunity to object (but none did). Including the Early Marden Rights in the IMAP does not require any additional notice to the public because all potentially affected persons already received adequate notice, and there is no statute, rule, or guideline requiring further notice.

If the Department determines that additional legal notice is necessary, only the Early Marden Rights should be advertised—it would not be necessary or appropriate to re-advertise the entire IMAP.

**	The figures in "CFS (after transfer)" reflect reductions resulting from the proposed elimination of combined or individual annual volume limitations and/or combined diversion rate limitations. These are addressed in pages 39-42 and 51-53 of <i>United Water's Statement Updating and Explaining the IMAP Relaunch</i> (Aug. 14, 2012) (" <i>Update Statement</i> "). As explained in the <i>Update Statement</i> , the annual volume limitations can be eliminated without enlarging the rights by reducing the rights' diversion rates to reflect the rates required to produce the annual volume based on a year-round continuous flow. Similarly, the combined diversion rate limitations can be eliminated without enlarging the rights by reducing the affected rights' diversion rates to match the combined flow limitation. Except where specifically noted, the reductions in this table correspond to figures in Tables 18 and 21 in the <i>Update Statement</i> . Where an individual volume limitation is proposed to be eliminated, it is reflected as "(limit removed)" under "AFA (after transfer)." 1	The IMAP proposes to eliminate the Veterans Collector point of diversion from right no. 63-02892, as well as the associated remark limiting diversions from the Veterans Collector to 5.00 cfs. The IMAP also proposes to eliminate the remark limiting diversions to 15 cfs under right nos. 63-02892, 63-31797, 63-31798, and 63-31879 because the rights' quantity elements total 15 cfs collectively, making the remark superfluous.
2	In addition to the rights' individual annual volume limitations shown in this table, right nos. 63-3457 and 63-10945 have a combined diversion rate of 3.10 cfs. As shown in Table 18 of the <i>Update Statement</i> , the annual volume limitations can be eliminated by reducing the rights as shown in this table. The rights' combined diversion rate also can be eliminated through these reductions because their total combined diversion rate would be 0.77 cfs.
3	Right nos. 63-4395, 63-8385, and 63-10150 have a combined diversion rate of 0.80 cfs and combined annual volume of 240.3 afa. Right nos. 63-8385 and 63-10150 also have individual annual volume limitations, as shown in this table. The IMAP proposes eliminating the combined diversion rate and combined and/or individual volume limitations on all three rights by reducing 63-4395 to 0.33 cfs ($240.3/365/1.9835=0.33$) and the other two rights (the junior rights) to 0.00 cfs. United Water recognizes that reducing right nos. 63-08385 and 63-10150 to 0.00 cfs effectively will make them obsolete
4	Right nos. 63-7641 and 63-8405 have a combined diversion rate of 3.12 cfs, or 0.88 cfs less than the total 4.0 cfs reflected on the face of both rights together. The IMAP proposes eliminating the combined diversion rate limitation on both rights by reducing right no. 63-8405 (the junior right) by 0.88 cfs, to 1.12 cfs. This reduction also accomplishes the proposed elimination of right no. 63-8405's 1,320 AFA volume limitation as shown in this table (and in Table 18 of the <i>Update Statement</i>).
5	Right nos. 63-11558 and 63-12363 have a combined diversion rate of 5.5 cfs, or 1.67 cfs less than the total 7.17 cfs reflected on the face of both rights together.
