AMENDED MITIGATION PLAN**



This withdrawal is made by reason of the Objections and Testimony filed herein by Clear Springs Food, Inc., objecting to all below-the-

rim deliveries of direct replacement water proposed by the Ground Water Districts in these Mitigation Plans.

It is the Ground Water Districts' intent to proceed with their Second Mitigation Plan for Monetary Compensation dated December 18, 2008.
