1. I am the past Chairman and a Board Member of the Aberdeen-American Falls  
Ground Water District. I am also the Chairman of the Idaho Ground Water Appropriators, Inc.  
("IGWA"). I make this affidavit based upon my own personal knowledge.

2. I am familiar with the Director's *Order Regarding April 2010 Forecast Supply (Methodology Steps 3 and 4)* ("As-Applied Order") I understand from the As-Applied Order that the Ground Water Users are required to report the volume of water they have acquired for mitigation by May 13, 2010. I have reviewed the *Notice Of Water Secured And Renewed Request For Stay* being submitted to the Director today. The information contained therein is true and correct.



Although IGWA has not yet been able to acquire the entire amount of water required by the As-Applied Order to avoid curtailment, IGWA has successfully obtained the water necessary to mitigate material injury in the past and I ask that the Director provide additional time to secure water before issuing a curtailment order.
