This Petition for Review of Orders Regarding Replacement Water Plans is filed on behalf of A & B Irrigation District, American Falls Reservoir District No. 2, Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company, and Twin Falls Canal Company (Coalition) in response to the Order Regarding IGWA Replacement Water Plan filed May 6, 2005, Order Regarding Simplot Replacement Water Request filed May 6, 2005, and Order Regarding Water Resource Coalition Replacement Water Plan filed May 6, 2005 (collectively referred to as "Replacement Water Plans Orders").

PROCEDURAL BACKGROUND

In response to that Order issued by the Idaho Department of Water Resources (Department) on April 19, 2005, as amended by that Amended Order issued May 2, 2005 (Order), the following "Replacement Water Plans" were filed: Idaho Ground Water Appropriators' Initial Plan for Replacing Water, J.R. Simplot Mitigation Plan, Water Resource Coalition Application for Approval of a Mitigation Plan (Amended May 5, 2005). In response to the Replacement Water Plans, on May 5, 2005, the Coalition filed the Surface Water Coalition's Protest, Objection, and Motion to Dismiss "Replacement Water Plans", the United States, Department of Interior, Bureau of Reclamation filed the Bureau of Reclamation's Protest to Idaho Ground Water Appropriators' Initial Plan for Providing Replacement Water on May 6, 2005 and Idaho Power Company filed Idaho Power Company's Protest to IGWA's Initial Plan for Providing Replacement Water on May 4, 2005 (Protests).

On May 6, 2005, the Department issued the Replacement Water Plan Orders. The Replacement Water Plan Orders do not address the Protests or the matters set forth in the Protests.

REQUEST FOR RELIEF


