COME NOW, Petitioners, TWIN FALLS CANAL COMPANY and NORTH SIDE CANAL COMPANY (hereinafter "Canal Companies"), by and through its attorneys, BARKER ROSHOLT & SIMPSON LLP, and hereby move the Director and/or the Idaho Department of Water Resources for a stay of the Director's *Order Modifying the Boundaries of the American Falls Ground Water Management Area* issued on August 29, 2003.


A stay of the August 29, 2003 Order is necessary to retain the original ground water management area designation pending resolution of the issues raised by the Canal Companies in its *Petition to Initiate Contested Case*. With continued declining spring flows and tributary reach gains expected into next year's irrigation season, the water supply in the original American Falls Ground Water Management Area remains "inadequate" to fully satisfy the Canal Companies' water rights. As such the Director should retain certain authorities and obligations set forth under I.C. § 42-233b. In addition, declining ground water levels in the Eastern Snake Plain

Aquifer (“ESPA”) requires that the ground water management area designation remain in place for purposes of protecting existing water supplies and in order to prevent the aquifer from becoming a “critical ground water area.”

This motion is made pursuant to IDAPA 37.01.01.260 and 37.01.01.780, and is supported by the record in this proceeding. The Canal Companies request an expedited hearing on this motion.
