Joint Petition for Stay

Aberdeen-Springfield Canal Company, Idaho Ground Water Appropriators, Inc., Twin Falls Canal Company, North Side Canal Company, A&B Irrigation District, American Falls Reservoir District No. 2, Burley Irrigation District, Minidoka Irrigation District, Milner Irrigation District, Idaho Dairymen's Association, City of Pocatello, and Falls Irrigation District—constituting all of the parties and potential intervenors in this matter—hereby petition the Director pursuant to Rule 780 of the IDWR Rules of Procedure to stay this matter until such time as any of the petitioners files a motion to resume proceedings.

The petitioners stipulate that upon such motion the Director may issue a scheduling order re-setting the deadline to respond to petitions to intervene that were timely filed under the Scheduling Order dated December 27, 2013, and re-setting the deadline for Statements of Procedural Issues.

In light of the pending January 21, 2014, deadline to respond to petitions to intervene, the petitioners respectfully ask the Director rule on this petition by January 17, 2014. The petitioners do not request oral argument on this petition.






